




#### PRESIDENT WALLS

Hello & welcome to your 2024 Spring Newsletter!

As Ward 4 Elizabeth Township Commissioner, I'm honored to have been appointed to serve as president of the Elizabeth Township Board of Commissioners. For the past two years, I served as vice president, active on numerous committees including budget & finance, personnel, code enforcement, and business development. I've learned much about the intricacies and challenges of local government, and I'm excited about the future of our township.

I am grateful for the opportunity to help make Elizabeth Township a better place to live and raise a family. I was raised to believe that serving your community is the best way to give back, and positive connections build a sense of unity and pride wherever we live. I've traveled to Africa, Haiti, Puerto Rico, and Turkey on missionary trips. Locally, I've been active with the Lions Club, Rotary, and the Elizabeth Township Historical Society – all pillars of our community.







Our Elizabeth Township Police Department offers an elite level of service to our community, covering one of the largest police service areas in Allegheny County. The hiring and expansion of our police department is offset by police service contracts from the communities we serve. Our residents enjoy a better staffed, equipped, and trained police force without a raise in their local taxes. The department has received praise and support from District Attorney Stephen Zappala. Our department works around the clock to make sure the message is loud and clear, Elizabeth Township enforces its laws, and if you break them, you are held accountable. In the past two years, we've hired six new officers, invested in life-saving technology, and raised the bar in the South Hills for community policing.

Our code enforcement and building inspector, along with our administration team, have worked hard to tackle blight, while undertaking the largest condemnation project in township history. Right now, thirty vacant and abandoned homes are in the process of being demolished. The goal is to eliminate the most dangerous structures first and continue this process to reduce hazards and risks to the community.

Our township manager, Greg Butler, has worked diligently to streamline internal processes to better prepare our team to move into the future. Greg, along with his administrative staff manage the day-to-day operation. Their dedication and commitment to providing excellent service to our community have not gone unnoticed. Whether it's coordinating projects, addressing inquiries, or their attention to detail, they consistently demonstrate a strong work ethic and professionalism.

In addition, Elizabeth Township has committed resources towards investing in recreation projects throughout the Township. The completion of the Mount Vernon basketball / pickle ball courts; the start of the Boston baseball & sports complex and the Highland Meadows Park upgrades to name a few. Along with the Elizabeth Forward High School remodel and upgrades, Elizabeth Township has committed to ensuring that this area is among the first choices for young people to locate and raise their families.

I believe heavily in communication and transparency. I encourage all residents to attend our regular or workshop monthly meetings on the first and third Monday of each month at 7 pm at the Elizabeth Township Municipal Building. I am thankful for this newsletter, as it works as an important tool to inform our nearly 13,000 residents of what is happening in their own backyards.

#### MANAGER'S MINUTE

Elizabeth Township is a First-Class Township that has seven commissioners representing seven wards within the township. Each commissioner has an enormous responsibility to represent the residents within their ward as well as ensuring the current stability of the township and determining the future direction of the township.

The Elizabeth Township Board of Commissioners has many responsibilities. They are the primary fiduciaries of the township revenues and expenses. They approve a yearly General Fund Budget and a yearly Sanitation Budget. They approve all tax rates that determine revenue as well as all expenses that are charged against that revenue. All said, these actions alone currently include approximately 15 million dollars every calendar year. Sanitary, road and recreation projects over the past several years have added many more millions of dollars to the fiscal decision-making of the commissioners.

The Board of Commissioners' other responsibility is Administrative, Public Works, and Police staffing. They must manage personnel salaries, collective bargaining contracts, benefits, and

pensions while remaining within budgetary constraints. They make difficult decisions related to the balance of staffing levels and how that affects the level and quality of public services provided by the township. How much staffing is too much and how much is too little?

The board must also appoint a Solicitor, Township Engineer, and Auditor. They must appoint residents to the Planning Commission, Zoning Hearing Board and Civil Service Commission. Many of the boards and commissions have appeal boards that must be filled with residents appointed by commissioners. These are all important appointments since these boards and commissions make decisions that also affect the current and future quality of life in the township.

I was a council member, the borough version of commissioner, for 18 years in another community. I fully understand the pressure and complexity of guiding a community. It requires constant attention that sometimes seems to take over your life. Despite the enormous effort and amount of energy, it is a real exercise in civil service that reaps rewards beyond words. You are helping current and future residents of the community. You are helping people live a good quality of life.

It is entirely possible that you do not agree with every decision made by an individual commissioner, or perhaps the board as a whole. It is important, though, to understand that these residents, and their families, dedicate an enormous part of their lives to making the most prudent and informed decisions possible for the community. They are charged with a great responsibility that would be difficult for any resident to fulfill. Feel free to thank them at a future meeting. I guarantee it will mean the world to them.

#### **ELIZABETH TOWNSHIP FIRE DEPARTMENT**

#### Chief Adam Janosko – ETFD #1



During the December 2023 of membership meeting Township the Elizabeth Fire Department #1, I was elected as the department's Fire Chief for 2024, replacing Chief John A. Walter who served the department well for the previous 7 years. I joined the ETFD in 2017 after serving with Munhall Volunteer Fire Department #1 since June 2001. Since joining ETFD, I

have served as a Lieutenant, Captain, and Deputy Fire Chief.

The ETFD currently operates from three fire stations which include Station 3 (Blythedale), Station 4 (Greenock) and Station 7 (Central) and provides primary fire and emergency services to the Elizabeth Township communities of Boston, Blythedale, Central Highlands, Greenock, Industry, Smithdale and Victory as well as providing mutual aid to our neighbors in Blaine Hill, Buena Vista, Elizabeth Borough, Forward, Liberty, Lincoln, Sutersville, and Versailles to name a few.

Recently, the ETFD purchased a 2008 Ferrara Quint with a 107' aerial ladder. This truck was purchased to replace and serve the function of two trucks. Due to the current price and production of a brand-new truck, this truck will be able to be put into service sooner and at a much more cost-efficient price. The truck is currently being outfitted for service to Elizabeth Township and should be seen around the township within the coming weeks. One of the trucks being replaced has already been sold to assist with offsetting the cost of the new truck. Additionally, the second truck being replaced is currently listed for sale.

Some of the goals of ETFD for 2024 are to get the new truck inservice, maintain manpower, continue building and maintaining relationships with neighboring departments, agencies and the community. As well as fundraising and locating/securing funding to offset the continuing rise of costs for purchasing and maintaining apparatus, equipment, buildings/facilities and training and education of members. The ETFD also looks forward to working with Southeast Regional EMS and continuing to build its QRS (Quick Response Services) responses which began in September 2023. It is anticipated that the ETFD 2024 call volume will increase from the 2023 call volume of 453 calls/incidents.



2560 Greenock Buena Vista Road is a property rich in history and memories with many stories to tell. What started as a two-room log cabin constructed in the early 1800s, quickly grew into a place of gathering and dedication when the Stieman family purchased the property in 1943. Valentine "Val" Stieman grew up in the small cabin and lived in the home for the duration of his life. Alongside his dedicated wife Pearl, Val Stieman took that two-room log cabin and - with several additions - turned it into an eleven-room, three-bathroom home that incorporated the carefully fitted logs from the original construction.

The Stieman's valued kindness and togetherness and often hosted lively gatherings with local groups including the Board of Commissioners and the

Lions Club. Pearl took a special interest in keeping an immaculate home and loved to host these memorable events in her historic home. True to his life of service and love of Elizabeth Township, Val gave up a job at the mill to pursue his dream of being a landscaper and left his mark on many recognizable grounds including the Yough Country Club and Mount Vernon Apartments. Using his landscaping talents, Val meticulously maintained roughly 30 gardens around the log cabin, each having its own theme. As a testament to his dedication to the community he proudly called home, Val dedicated 28 years of his life as an Elizabeth Township Commissioner, an accomplishment his granddaughter LaRae Stieman says he was

On September 9, 2023, the Elizabeth Township Board of Commissioners, State Senator Jim Brewster, State Representative Andrew Kuzma, residents of Smithdale, and members of the Charles Carlock family attended a ceremony at the bottom of Forest Hill Road.

The ceremony celebrated the nicknaming of Forest Hill Road to "Carlock's Pass" in dedication of Charles "Yip" Carlock, a Smithdale resident that served on the Elizabeth Township Board of Commissioners for 48 years. The nickname "Carlock's Pass" was legally adopted by the Elizabeth Township Board of Commissioners through Resolution.

Mr. Carlock was responsible for establishing the Police Department, expanding the Public Works Department, purchasing land to build Municipal Baseball Field, installing lights at Boston Baseball Field, establishing the Elizabeth Township Area EMS, and spearheading construction of the existing municipal building partially with grant funding.

Mr. Carlock also served on the executive committee of the Pennsylvania Association of Township Commissioners for 37 years. He was on the executive board of the Allegheny County and Western Pennsylvania Association of Township Commissioners for 40 years. He was also active in the Allegheny League of Municipalities

#### RECENT INFRASTRUCTURE AND FACILITY IMPROVEMENTS

The Elizabeth Township Board of Commissioners has recently approved funding for several improvements throughout the Township. The approved improvements include the following:

- Complete replacement of the Jacktown Road bridge coming off Lovedale Road.
- Remediation of landslides on Jacktown Road.
- Converting traffic signal lights to LED lights at Lovedale/McKeesport Road and at the Boston Bridge.
- Installation of 12 garage doors at the Public Works garage.
- Demolition of 21 blighted homes throughout the Township.
- Installation of a new sign and decorative ground cover at the Township Municipal Building.
- Replacement of a small bridge on Circle Drive.

#### MS4

MS4 stands for Municipal Separate Storm Sewer Systems which are systems or conveyances that drain stormwater runoff. This includes catch basins, storm sewers owned and operated by public or private entities, channels, ditches, curbs, etc. and is not part of a combined or sanitary sewer system.

A Municipality is bound by the US Environmental Protection Agency (EPA) and the Pennsylvania Department of Environmental Protection (PADEP) to meet the state and

federal stormwater regulations associated with the federal Clean Water Act under the MS4 Program. A municipality is

considered an MS4 when it lies within any urbanized area within the municipal boundaries.

Elizabeth Township is currently considered an MS4 Permittee which is administered and managed by the PADEP. Through this permit the Township is required to develop a stormwater management plan that informs the general public, residents, businesses, employees, etc. how to manage stormwater and avoid pollutants from entering our streams such as sediment, metals, fecal matter, oils and grease, fertilizers, garbage, and more while complying with the MS4 permit requirements.

#### **SELLING A PROPERTY IN ELIZABETH TOWNSHIP**

Selling a property in Elizabeth Township has requirements that must be completed prior to closing. You will need to send in for a Municipal and Sewer No-Lien Letter. Each of these letters cost \$40.00 and checks must be separate and made out to "Elizabeth Township" and "Elizabeth Township Sanitary", respectively. Each letter should include, whether the request is for a purchase or a refinance of the property, the seller's and purchaser's names, the property address, the parcel ID, and the closing date. Please also note on the sewer no-lien letter if the property has a septic tank.

You will also need to have a dye test done. You do not pay the Township directly for the dye test, rather you pay a plumber who

is licensed in Allegheny County to perform the dye test and pay them directly. A member of our sanitary department must be present during the dye test for the test to be considered valid. To schedule a time with our sanitary department, please call 412-751-8180 option 1.

An occupancy inspection with our Code Enforcement Officer is also required. The cost of the inspection is \$100.00. You will find the application for the Certificate of Occupancy (and further information on all the requirements) on our website at www.elizabethtownshippa.com/property-sale-information.

#### TAX COLLECTION

Beginning April 1st, 2024, the tax collector, Mary Walos, will be in the office on Mondays, Tuesdays, and Thursdays from 8:30 am – 3:30 pm. These hours will be in effect until November 2024. From November to March, the tax collector will be in the office on Tuesday and Thursdays from 9:00 am – 3:00 pm. The tax office will be closed from 12:00 pm – 12:30 pm for lunch.

The preferred method of tax payment is utilizing the black

drop box located outside of the Municipal Building labeled "TAXES". If you'd like a receipt, please include a self-addressed stamped envelope with your drop-off. You are still able to come into the building to pay your taxes during the Tax Collectors normal hours, but you must ring the doorbell on the front door to be let inside the building. Credit card and cash payments are not accepted.

#### **ACT 77 - SENIOR TAX RELIEF**

Elizabeth Township participated in Allegheny County's Act 77 for Senior Tax Relief. To take advantage of this program, applicants must reach the following three requirements:

- Must have owned or occupied a primary residence in Allegheny County continuously for the past 10 years
- Must be 60 or older
- Gross household income must be \$30,000.00 or less

The program features a flat 30% discount of the real property tax for Allegheny County. Acceptance into this program also ensures a 10% discount in Elizabeth Township local tax. #### FORMER BUSINESS OWNER GIVES BACK



#### **NEW FALL LEAF PICK-UP RULES**

- 1) All leaves must be in a pile and placed no more than 5ft. from the gutter line (edge) of the street.
- 2) If the leaves cannot be reached by the leaf vacuum machine they will not be collected.
- 3) Leaves will be picked up by zone on a daily schedule. The schedule can be found online at www.elizabethtwppa.com and by the corresponding map.
- 4) All leaves that are dropped off at the township building on the LAST Thursday of the month must be bagged.
- 5) Sticks, branches, and other yard waste will not be picked up on leaf collection days. Those items can be taken to the township building on the LAST Thursday of the month.
- 6) All complaints can be addressed by filling out the leaf pick-up request form found on the "Public Works" page of the Township website.
- Leak pick-up will begin and end on an as needed basis. Dates will be published when available.

#### **HOW TO AVOID A SCAM**

# $Four_{ m signs}$ that it's a scam

Scammers PRETEND to be from an organization you know. Scammers often pretend to be contacting you on behalf of the government. They might use a real name, like the Social Security Administration, the IRS, or Medicare, or make up a name that sounds official. Some pretend to be from a business you know, like a utility company, a tech company, or even a charity asking for

donations. They use technology to change the phone number that appears on your caller ID. So the name and number you see might not be real.

- Scammers say there's a PROBLEM or a PRIZE. They might say you're in trouble with the government. Or you owe money. Or someone in your family had an emergency. Or that there's a virus on your computer. Some scammers say there's a problem with one of your accounts and that you need to verify some information. Others will lie and say you won money in a lottery or sweepstakes but have to pay a fee to get it.
- Scammers PRESSURE you to act immediately. Scammers want you to act before you have time to think. If you're on the phone, they might tell you not to hang up so you can't check out their story. They might threaten to arrest you, sue you, take away your driver's or business license, or deport you. They might say your computer is about to be corrupted.
- Scammers tell you to PAY in a specific way. They often insist that you pay by sending money through a money transfer company or by putting money on a gift card and then giving them the number on the back. Some will send you a check (that will later turn out to be fake), tell you to deposit it, and then send them money.

#### WHAT YOU CAN DO TO AVOID A SCAM

- Block unwanted calls and text messages. Take steps to block unwanted calls and to filter unwanted text messages.
- Don't give your personal or financial information in response to a request that you didn't expect. Legitimate organizations won't call, email, or text to ask for your personal information, such as your Social Security, bank account, or credit card numbers. If you get an email or text message from a company you do business with and you think it's real, it's still best not to click on any links. Instead, contact them using a website you know is trustworthy. Or look up their phone number. Don't call a number they gave you or the number from your caller ID.
- Resist the pressure to act immediately. Legitimate businesses will give you time to make a decision. Anyone who pressures you to pay or give them your personal information is a scammer.
- Know how scammers tell you to pay. Never pay someone who insists you pay with a gift card or by using a money transfer service. And never deposit a check and send money back to someone.
- Stop and talk to someone you trust. Before you do anything else, tell someone a friend, a family member, a neighbor what happened. Talking about it could help you realize it's a scam.

# 5 STEPS for Creating a Rain Garden

#### Stormwater runoff is a major cause of water pollution in streams and rivers

ain gardens are shallow depressions that are planted with deep-rooted native and non-native adaptive plants and grasses. They are:

- Designed to collect rain water that runs off rooftops or lawns
- · Areas that capture stormwater runoff, allowing it to soak into the ground. This recharges groundwater and naturally filters out pollutants.
- · A source of food and habitat for birds and butterflies

Creating a rain garden not only shows your interest in protecting the environment, but also can be a beautiful addition to a home landscape.



#### **5 STEPS FOR CREATING A RAIN GARDEN**



#### Pick the spot

- Contact local utilities by calling 811 to have them mark locations of underground wires, cables, or pipes
- A rain garden should be at least 10 feet from foundations and fence posts, and 25 feet from septic system drain fields and well heads



#### Outline garden and determine depth

- The average size of a home rain garden is 70 square feet (7 x 10 feet), but the size can vary based on how much water you want to catch
- Gardens should be no more than 6 to 12 inches deep
- Make sure the garden is not flat because you need a depression to capture water



#### Select the plants

- Select native and non-native adaptive plants that can tolerate "wet feet" in the lowest places
- Determine how many plants are needed based on your rain garden size and the mature plant dimensions



#### Dig in

- The depression in your rain garden should be marked and dug to the depth you determined in Step 2.
- Without a depression, the rain garden will not work.
- Make sure not to compact the soil this is the leading cause of failed gardens
- Place each plant at its minimum distance from other plants



#### Finish-Up

- Install mulch or sphagnum moss to keep weeds out and retain moisture
- Water the garden each day for the first week, and then gradually reduce watering over the next three weeks. After a month, normal rain should be enough to keep plants healthy.
- Regular maintenance is required to keep your rain garden looking good and functioning well

- Tips for Managing Your Rain Garden
  Don't worry about mosquitoes. Your rain garden should not retain water long enough for mosquitoes to have an opportunity to breed
  Your rain garden will contain flow from light rains, however, will fill up and overflow during heavy rains
  You may direct your downspout to the rain garden by digging a shallow swale or by routing it through a drain pipe
  If your soil lacks organic material, you may dig the depression an additional 2 to 3 inches and fill in with peat moss or compost
  Be creative by adding decorative items such as stones and garden ornaments to enhance your rain garden



# HOW TO STAY SAFE when a thunderstorm threatens

Lightning is a leading cause of injury and death from weather-related hazards



- Know your area's risk of thunderstorms. They can occur year-round and at any hour.
- Sign up for your community's warning system. The Emergency Alert System (EAS) and National Oceanic and Atmospheric Administration (NOAA) Weather Radio also provide emergency alerts.
- **Identify sturdy buildings close** to where you live, work, study, and play.
- **Cut down or trim trees** that may be in danger of falling on your home.
- Consider buying surge protectors, lightning rods, or a lightning protection system to protect your home, appliances, and electronic devices.
- · Secure outside furniture.



- When thunder roars, go indoors. A sturdy building is the safest place to be during a thunderstorm.
- Pay attention to weather reports and warnings of thunderstorms. Be ready to change plans, if necessary, to be near shelter.
- When you receive a thunderstorm warning or hear thunder, go inside immediately.

Do not use landline phones.



- If indoors, avoid running water or using landline phones. Electricity can travel through plumbing and phone lines.
- Protect your property. Unplug appliances and other electric devices.
- If boating or swimming, get to land and find a sturdy, grounded shelter or vehicle immediately.
- If necessary, take shelter in a car with a metal top and sides. Do not touch anything metal.
- Avoid flooded roadways. Turn Around Don't Drown®. Just six inches of fast-moving water can knock you down, and one foot of moving water can sweep your vehicle away.



- **Listen to authorities and weather forecasts** for information on whether it is safe to go outside and instructions regarding potential flash flooding.
- Watch for fallen power lines and trees. Report them immediately.
